In the execution of this Power of Attorney the said attorney is specially authorized and empowered to receive all communications, plaints and other notices; to give declarations, in his/their name; to lodge plaints with the Patent Office, the Courts and any other Authorities in any Penal or Civil Proceedings or to withdraw the same; to raise objection; to appeal and to have recourse to other legal measures and to withdraw the same; to submit to arbitration; to offer and to accept a oath; to attend the execution of sentences; to apply for judicial securities and to cancel same; to compromise; to withdraw any application and any registered right of industrial property; to substitute all or any part of the present power; and to do generally all that may be necessary according to the laws to secure to the grantor the privileges above mentioned.
